Representing Pokro Brewing was Joe Pokropinski of 637 Rensselaer Griffith, IN.. Per Mr. Propinski he would like to open a Micro-Brewery. The beer will be manufactured on the property for sales and purchasing. No food will be served at this time. Operating hours will be Friday 3 till 9, Saturday 12 till 9 & Sunday 12 till 4. Parking will be shared with Bozo Hotdogs. There will be a tasting room. He would like to open in June. At this point there was a discussion regarding the statues of a Micro-Brewery selling beer on a Sunday, type of equipment, size of building and how many people it will hold. There being no further questions from the Board of Zoning Appeals, Mr. Kus made the motion to grant permission to Pokro Brewing Company of 311 N Broad Street permission for a Public Hearing for a Special Use to allow a Micro-Brewery in a B2 Zoning District.
