RESOLUTION OF THE TOWN OF GRIFFITH PLAN COMMISSION APPROVING AMENDMENTS TO A DECLARATORY RESOLUTION APPROVED AND ADOPTED BY THE TOWN OF GRIFFITH REDEVELOPMENT COMMISSION

WHEREAS, the Town of Griffith Plan Commission (the "Plan Commission") is the body charged with the duty of developing a general plan of development for the Town of Griffith, Indiana (the "Town"); and

WHEREAS, pursuant to IC 36-7-14, as amended (the "Act"), the Town of Griffith Redevelopment Commission (the "Redevelopment Commission") previously adopted and amended a Declaratory Resolution (the "Declaratory Resolution") establishing an economic development area (the "Economic Development Area") and an Allocation Area therein designated as the "Downtown Griffith Redevelopment District" (the "Original Allocation Area"), as expanded in 2015 (the Original Allocation Area, as so expanded, the "Allocation Area") in the Town, and approving the Griffith Amended Redevelopment Plan for the Economic Development Area (the "Plan"); and

WHEREAS, on October 8, 2019, the Redevelopment Commission approved and adopted a Resolution (the "2019 Resolution") amending the Declaratory Resolution and the Plan by (i) removing the parcels listed in <u>Exhibit A</u> attached thereto (the "2019 Parcels") from the Allocation Area and simultaneously adding the 2019 Parcels back into the Allocation Area, (ii) designating the area as described on <u>Exhibit B</u> attached thereto as an additional allocation area (the "2019 Allocation Area") within the existing Economic Development Area, (iii) extending the expiration date of the Original Allocation Area to 25 years after the date on which the first obligation is incurred, as permitted by Section 39(b) of the Act, and (iv) adopting a supplement to the Plan attached thereto as <u>Exhibit C</u> (the "2019 Plan Supplement") (clauses (i), (ii), (iii) and (iv), collectively, the "2019 Amendments"); and

WHEREAS, the Redevelopment Commission has submitted the 2019 Resolution to the Plan Commission for its approval pursuant to IC 36-7-14-16;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF GRIFFITH PLAN COMMISSION, as follows:

1. The 2019 Resolution and the 2019 Amendments to the Plan contained therein conform to the plan of development for the Town.

2. This Plan Commission hereby approves the 2019 Resolution and the 2019 Amendments to the Plan contained therein. This resolution hereby constitutes the written order of the Plan Commission approving the 2019 Resolution and the 2019 Amendments to the Plan contained therein pursuant to IC 36-7-14-16.

3. The Secretary of this Plan Commission is hereby directed to file a copy of the 2019 Resolution with the minutes of this meeting.

RESOLUTION OF THE TOWN OF GRIFFITH PLAN COMMISSION APPROVING AMENDMENTS TO A DECLARATORY RESOLUTION APPROVED AND ADOPTED BY THE TOWN OF GRIFFITH REDEVELOPMENT COMMISSION

WHEREAS, the Town of Griffith Plan Commission (the "Plan Commission") is the body charged with the duty of developing a general plan of development for the Town of Griffith, Indiana (the "Town"); and

WHEREAS, the Town of Griffith Redevelopment Commission (the "Redevelopment Commission") previously adopted and amended a Declaratory Resolution (the "Declaratory Resolution") establishing an area needing redevelopment (the "Redevelopment Area") and designating certain portions thereof as allocation areas, including the Cline Avenue Redevelopment Area Allocation Area (the "Cline Avenue Allocation Area") and the Griffith Mall Redevelopment Area Allocation Area (the "Mall Allocation Area"), and approving the Griffith Amended Redevelopment Plan for the Redevelopment Area (the "Plan"); and

WHEREAS, on October 8, 2019, the Redevelopment Commission approved and adopted a Resolution (the "2019 Resolution") amending the Declaratory Resolution and the Plan by (i) removing the parcels listed in <u>Exhibit A</u> attached thereto (the "2019 Parcels") from the Cline Avenue Allocation Area and simultaneously adding the 2019 Parcels back into the Cline Avenue Allocation Area, and (ii) consolidating the Cline Avenue Allocation Area and the Mall Allocation Area into a single allocation area designated as the "Consolidated Griffith Redevelopment Area Allocation Area" (clauses (i) and (ii), collectively, the "2019 Amendments"); and

WHEREAS, the Redevelopment Commission has submitted the 2019 Resolution to the Plan Commission for its approval pursuant to IC 36-7-14-16;

NOW, THEREFORE, BE IT RESOLVED BY THE TOWN OF GRIFFITH PLAN COMMISSION, as follows:

1. The 2019 Resolution and the 2019 Amendments to the Plan contained therein conform to the plan of development for the Town.
