

ORDINANCE NO. 2013-09

AN ORDINANCE AMENDING CHAPTER 74 TRAFFIC AND VEHICLES, ARTICLE VIII TRAFFIC SCHEDULES, SECTION 74-294 STOP SIGNS FOR NEW SUBDIVISIONS, TO INSTALL STOP SIGNS IN THE WEST-HAVEN MANOR AND TRAIL CREEK SUBDIVISIONS.

WHEREAS, IC 36-1-3-2 confers upon all local units the powers that they need for the effective operation of government as to local affairs; and

WHEREAS, IC 36-1-3-6(b)(1) prescribes that any such exercise of power shall be authorized through enactment of an ordinance passed by the legislative body; and

WHEREAS, the Town of Griffith is a municipal government located in Lake County, Indiana, which may pass and codify ordinances for its operation, all pursuant to IC 36-1-4 and IC 36-1-5; and

WHEREAS, the Town of Griffith, through its Town Council, now desires to install stop signs within the West-Haven Manor and Trail Creek Subdivisions, both of which are located within the Town of Griffith; and

WHEREAS, the installation of stop signs within the West-Haven Manor and Trail Creek Subdivisions will serve to promote the public health, safety, and welfare of the residents of the Town of Griffith, motorists, and pedestrians; and

NOW, THEREFORE, BE IT FURTHER ORDAINED, by the Town Council of the Town of Griffith that Municipal Code, Chapter 74 Traffic and Vehicles, Article VIII. Traffic Schedules, Section 74-294 Stop signs for new subdivisions, shall hereinafter be amended to read as follows:

(c) *West-Haven Manor.*

| Streets | Direction |
|--|--------------------------|
| Harvey Avenue and 43 rd Court | North, south, east, west |
| 43 rd Place and Cline Avenue | West |

(d) *Trail Creek.*


| Streets | Direction |
|--------------------------------------|--------------|
| Trail Creek Drive and Sawgrass Drive | North, south |
| Trail Creek Drive and Thistle Drive | South |
| Thistle Drive and Clover Lane | South |
| Clover Lane and Sawgrass Drive | North |

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.



PASSED AND ADOPTED by the Town Council for the Town of Griffith, Lake County, Indiana this 16th day of April, 2013.




