

## ORDINANCE NO. 2015 - 23

### AN ORDINANCE OF THE TOWN OF GRIFFITH, LAKE COUNTY, INDIANA VACATING A PORTION OF LILLIAN STREET, A PUBLIC ROADWAY WITHIN THE TOWN OF GRIFFITH

**WHEREAS**, the Griffith Town Council, under the authority of I.C. 36-7-3-12 et seq., wishes to vacate a portion of a public way; and

**WHEREAS**, the Griffith Town Council, pursuant to law, held a public hearing to vacate said public way; and

**WHEREAS**, the Griffith Town Council, at a duly constituted meeting, determined that said way be vacated;

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF GRIFFITH, LAKE COUNTY, INDIANA**, that the petition to vacate the following described real estate lying in the Town of Griffith, Lake County, Indiana is granted and the public way described is vacated, to wit:

Lillian Street (a 33.0 foot right-of-way) as shown on Block 2 in Ridgewood Addition to the Town of Griffith, Lake County, Indiana, as per plat thereof, recorded in Plat Book 2, page 80 in the Office of the Recorder of Lake County, Indiana. Lying southerly of platted Chicago and Grand Trunk Railroad now Grand Trunk and Western Railroad.

**NOW, THEREFORE, BE IT FURTHER ORDAINED**, that the Clerk-Treasurer is authorized and directed to publish this Ordinance as required by Indiana law and to file a certified copy of said Ordinance with the Auditor of Lake County, Indiana for the Auditor to take all necessary action in connection with taxation of the vacated public way.

**NOW, THEREFORE, BE IT FURTHER ORDAINED**, that the Clerk-Treasurer is further authorized and directed to record a copy of this Ordinance with the Lake County Recorder.


**NOW, THEREFORE, BE IT FURTHER ORDAINED**, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

**NOW, THEREFORE, BE IT FURTHER ORDAINED**, that this Ordinance shall be in full force and effect after its passage and posting in accordance with IC 36-5-2-10.


