ORDINANCE NO. 2017-47

AN ORDINANCE AMENDING CHAPTER 74 TRAFFIC AND VEHICLES, ARTICLE VIII TRAFFIC SCHEDULES, SECTION 74-294 STOP SIGNS FOR NEW SUBDIVISION, TO INSTALL STOP SIGNS IN THE TURNBERRY SUBDIVISION

WHEREAS, IC 36-1-3-2 confers upon all local units the powers that they need for the effective operation of government as to local affairs; and

WHEREAS, IC 36-1-3-6(b)(1) prescribes that any such exercise of power shall be authorized through enactment of an ordinance passed by the legislative body; and

WHEREAS, the Town of Griffith is a municipal government located in Lake County, Indiana, which may pass and codify ordinances for its operation, all pursuant to IC 36-1-4 and IC 36-1-5; and

WHEREAS, the Town of Griffith, through its Town Council, now desires to install stop signs within the Turnberry Subdivision, which is located within the Town of Griffith; and

WHEREAS, the installation of stop signs within the Turnberry Subdivision will serve to promote the public health, safety, and welfare of the residents of the Town of Griffith, motorists, and pedestrians; and

NOW, THEREFORE, BE IT FURTHER ORDAINED, by the Town Council of the Town of Griffith that Municipal Code, Chapter 74 Traffic and Vehicles, Article VIII. Traffic Schedules, Section 74-294 Stop signs for the new subdivision, shall hereinafter be amended by the addition of the following:

(5) Turnberry.

Streets/Intersections	Direction
Trail Creek Drive at its intersection with the bike trail	East, West
Trail Creek Drive and Turnberry Road	North, South, East
Glasgow Drive and Turnberry Circle	North, South, East, West

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after its passage and posting in accordance with Indiana Code 36-5-2-10.
