ORDINANCE NO.: 2018-37

AN ORDINANCE AMENDING TOWN CODE SECTION 74-301 ENTITLED "PARKING PROHIBITED AT ALL TIMES", AND REPEALING ALL TOWN CODE SECTIONS AND ORDINANCES, OR PARTS THEREOF, IN CONFLICT HEREWITH.

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has reviewed the Traffic and Vehicles Provisions as set forth in the Town Code; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has been advised that amendments are required to Town Code Section 74-301 pertaining to certain areas on streets in the Town upon which parking shall be prohibited at all times; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has determined that it is necessary and advisable to amend Town Code Section 74-301 pertaining to certain areas on streets in the Town upon which parking shall be prohibited at all times; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, having reviewed the relevant Town Code sections and all applicable law, now concurs that it is advisable, necessary, and in the best interests of the residents of the Town of Griffith that amendment be made to the Town Code pertaining to certain areas on streets in the Town upon which parking shall be prohibited at all times.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GRIFFITH, LAKE COUNTY, INDIANA:

SECTION ONE: That Town Code Section 74-301, entitled <u>PARKING PROHIBITED</u> <u>AT ALL TIMES.</u>, of Chapter 74, entitled <u>TRAFFIC AND VEHICLES</u>, of the Griffith Town Code, be, and the same is hereby amended to add the following streets to the schedule under subsection (a), namely:

"Sec. 74-301. - PARKING PROHIBITED AT ALL TIMES.

(a) No person shall stop, stand, or park in any motor vehicle in the following locations:

Street	Description
South Broad	The east side of South Broad from Main Street to Avenue A.
South Broad	The west side of South Broad from Main Street to 106 South Broad, approximately fifty (50") feet south of Main Street"

<u>SECTION TWO</u>: That all existing Ordinances, and Town Code Section, or parts thereof, in conflict with the provisions of this Ordinance are hereby deemed null, void, and of no legal effect, and are specifically repealed.

<u>SECTION THREE</u>: If any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance.

SECTION FOUR: That this Ordinance shall take effect, and be in full force and effect, from and after its passage by the Town Council of the Town of Griffith, Lake County, Indiana.
