ORDINANCE NO.: 2019-02

AN ORDINANCE AMENDING TOWN CODE SECTION 62-80 ENTITLED "PLACEMENT", AND REPEALING ALL TOWN CODE SECTIONS AND ORDINANCES, OR PARTS THEREOF, IN CONFLICT HEREWITH.

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has reviewed the Solid Waste Provisions as set forth in the Town Code; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has been advised that amendments are required to Town Code Section 62-80 pertaining to the placement of containers for the deposit of garbage, rubbish or recycling items; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has determined that it is necessary and advisable to amend Town Code Section 62-80 pertaining to the placement of containers for the deposit of garbage, rubbish or recycling items; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, having reviewed the relevant Town Code sections and all applicable law, now concurs that it is advisable, necessary, and in the best interests of the residents of the Town of Griffith that amendment be made to the Town Code pertaining to the placement of containers for the deposit of garbage, rubbish or recycling items.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GRIFFITH, LAKE COUNTY, INDIANA:

SECTION ONE: That Town Code Section 62-80, entitled PLACEMENT, of Chapter 62, entitled SOLID WASTE, of the Griffith Town Code, be, and the same is hereby amended as follows:

"Sec. 62-80 - Placement

- a) All containers for the deposit of garbage, rubbish or recycling items shall be located upon the alley line or a place readily accessible for removing and emptying them in such a manner as to not interfere with the use of the alley
- b) In those premises wherein the collection and removal of garbage is not accomplished by use of an alley, the containers should be placed adjacent to the street in a neat, orderly, and sanitary manner on the designated day or day before the collection and removal of garbage, rubbish and recycling items by the town.

- c) All containers shall be removed from the collection site (street or alley) on the day collection is made.
- d) Exposed storage of all containers shall not be kept beyond the nearest portion of the residence's main structure to a street, not including any front porch."

SECTION TWO: That all existing Ordinances, and Town Code Section, or parts thereof, in conflict with the provisions of this Ordinance are hereby deemed null, void, and of no legal effect, and are specifically repealed.

SECTION THREE: If any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance.

SECTION FOUR: That this Ordinance shall take effect, and be in full force and effect, from and after its passage by the Town Council of the Town of Griffith, Lake County, Indiana.
