

TOWN OF GRIFFITH, LAKE COUNTY, INDIANA
ORDINANCE NO: 2019-15

**AN ORDINANCE AMENDING TOWN CODE SECTION 74-302 ENTITLED
“LIMITED PARKING ON CERTAIN STREETS”, AND REPEALING ALL
TOWN CODE SECTIONS AND ORDINANCES, OR PARTS THEREOF, IN
CONFLICT HEREWITH.**

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has reviewed the provisions of Town Code Section 74-301 and Town Code Section 74-302 as set forth in the Town Code; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has been advised that amendments are required to Town Code Section 74-301 and Town Code Section 74-302; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has determined that it is necessary and advisable to amend Town Code Section 74-301 and Town Council Section 74-302; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, having reviewed the relevant Town Code sections and all applicable law, now concurs that it is advisable, necessary, and in the best interests of the residents of the Town of Griffith that amendment be made to the Town Code.

**NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE
TOWN OF GRIFFITH, LAKE COUNTY, INDIANA, AS FOLLOWS:**

SECTION ONE: That Town Code Sec. 74-301, entitled **Parking prohibited at all times**, is hereby amended and restated to read and provide as follows, namely:

“Sec. 74-301.-Parking prohibited at all times.

- (a) No person shall stop, stand or park any motor vehicle in fire lanes as marked and in the following locations:

Street	Description
Arbogast Avenue	The east side, 40 th Avenue to Ridge Road
Broad Street	The east side of Broad Street from Main Street south 400 feet to the alley at the south property line of the 100 block of Broad Street.
North Wheeler Avenue	East side of the 800 block from the intersection of East 45 th Avenue south approximately 360 feet to the south property line of Lot 1 of 45 th and Colfax Branch Library Addition to

	the Town of Griffith
Elmer Avenue	The west side, from the south limit of the apartment complex located adjacent thereto, to Ash Avenue
West Main Street	The south side between Cline Avenue and Broad Street.
West Main Street	The north side from Broad Street to the east side of the Erie Lakawana Bike Trail
45 th (Glen Park Avenue)	Both sides within corporate limits

SECTION TWO: That Town Code **Sec. 74-302**, entitled **Limited parking on certain streets**, is hereby amended and restated to read and provide as follows, namely:

“Sec. 74-302. - Limited parking on certain streets.

- (a) *Definition.* The word resident as used in this section shall be construed to apply only to owners or occupiers (or respective invitees) of dwellings which immediately abut the street upon which the sign is posted.
- (b) The Town may from time to time establish 20-minute parking spots to accommodate temporary parking needs in the commercial areas within Town limits. These spots will be marked by appropriate signage noting the limitation in parking. Violations are subject to ticketed fines pursuant to the applicable code violations for improper parking.
- (c) The Town may from time to time establish other limited parking spots to accommodate parking needs within Town limits. These spots will be marked by appropriate signage noting the limitation in parking. Violations are subject to ticketed fines pursuant to the applicable code violations for improper parking.
- (d) Parking is hereby limited, as described on the following streets:

SECTION TWO: That all existing Town Code Sections and Ordinances, or parts thereof, in conflict with the provisions of this Ordinance, are hereby deemed null, void, and of no legal effect, and are specifically repealed.

SECTION THREE: If any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance.


