**A RESOLUTION RECOMMENDING ESTABLISHMENT OF FEES  
PERTAINING TO THE TOWING OF VEHICLES BY THE  
POLICE DEPARTMENT IN THE TOWN OF GRIFFITH, LAKE  
COUNTY, INDIANA, AND ALL RELATED MATTERS.**

**WHEREAS**, the Safety Board of the Town of Griffith, Lake County, Indiana, is a duly organized and established entity established by enabling Ordinance of the Town of Griffith, Lake County, Indiana, authorized and empowered by statutory authority to make general and special rules for the government and discipline of the Town Police Department, as well as to make special and general rules to the Department through the Police Chief, the Executive Head of the Police Department; and

**WHEREAS**, it has been undertaken and been a part of the duties of the Safety Board to

**WHEREAS**, it has been advised and informed that the towing fees established by the Safety Board are advisable to be established; and

**WHEREAS**, the Safety Board of the Town of Griffith, Lake County, Indiana, has determined based upon the recommendation of the Chief of Police that vehicle towing fees are necessary to assure that proper and adequate public safety and police services are provided for the health, safety, general welfare and well-being of the residents of the Town; and

**WHEREAS**, the Safety Board of the Town of Griffith, Lake County, Indiana, now determines that it is in the best interests of the residents of the Town of Griffith and the Griffith Police Department to establish vehicle towing fees charged by the Griffith Police Department for the public health, safety, general welfare and well-being of the residents of the Town.

**NOW, THEREFORE BE IT RESOLVED BY THE SAFETY BOARD OF THE TOWN OF GRIFFITH, LAKE COUNTY, INDIANA:**

**SECTION ONE:** That a favorable recommendation is hereby certified and transmitted to the Griffith Town Council to take all appropriate and legal measures to approve and adopt an Ordinance establishing vehicle towing fees as set forth in the proposed Town Ordinance attached hereto at the earliest opportunity.

**SECTION TWO:** That this Resolution shall take effect, and be in full force and effect, from and after passage by the Safety Board of the Town of Griffith, Lake County, Indiana.
