ORDINANCE NO. 2021- 22

AN ORDINANCE AMENDING SECTION 14-106 FEES GENERALLY OF CHAPTER 14 BUILDINGS AND BUILDING REGULATIONS, ARTICLE II. BUILDING CODE, DIVISION 5. FEES AND CHARGES,

WHEREAS, IC 36-1-32-2 confers on all local units of government the powers that they need for the effective operation of government as to local affairs; and

WHEREAS, IC 36-1-3-6(b) (1) prescribes that any such power shall be authorized through the enactment of an ordinance passed by the legislative body; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana believes it is in the best interest of the citizens of the Town and contractors working within the Town that the Schedule of Fees and Charges be revised to be more user friendly and easily understandable.

NOW, THEREFORE, BE IT ORDAINED, by the Town Council of the Town of Griffith, Lake County, Indiana, that Chapter 14 section 14-106 fees generally of Chapter 14 buildings and building regulations, Article II. Building code, Division 5. fees and charges is hereby amended as follows:

Sec. 14-106. - Fees generally.

The following fees to be charged by the Town of Griffith for the inspections required and for the permits issued under its Code of Ordinances shall hereinafter be contained in this section as amended from time to time and shall replace any and all fees for inspections and issuing permits that are a conflict herewith.

Project fees. Includes Building, Plumbing, Electrical, and HVAC permits.

- Project valuation fees are based on 1% valuation¹ of total project cost (materials and labor). \$30 minimum fee. No charge for individual permits. Each permit must still be applied for and approved as a total project.
- -No building permit required for non-structural residential remodeling under \$500 total cost. Total cost includes labor and material totals. Does not include plumbing, electrical or HVAC permits.

Inspections (Includes all Building, Plumbing, Electrical, and HVAC inspections)

- All inspections are \$30
- Re-inspections are \$30

Certificate of Occupancy (COO)

- Residential \$50
- Commercial \$75
- -For new construction in order to obtain a certificate of occupancy, all inspections must be satisfied and a final plat with grade elevations and elevation of first floor must be submitted.
