

TOWN OF GRIFFITH, LAKE COUNTY, INDIANA

ORDINANCE NO: 2022-39

AN ORDINANCE AMENDING TOWN CODE SECTION 74-174 ENTITLED “REGULATIONS FOR THE STOPPING, STANDING AND PARKING OF ALL MOTOR VEHICLES INCLUDING BUT NOT LIMITED TO MOTORCYCLES”, AND REPEALING ALL TOWN CODE SECTIONS AND ORDINANCES, OR PARTS THEREOF, IN CONFLICT HEREWITH.

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has reviewed the provisions of Town Code Section 74-174 as set forth in the Town Code; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has been advised that amendments are required to Town Code Section 74-174 pertaining to regulations for the stopping, standing and parking of all motor vehicles including but not limited to motorcycles; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, has determined that it is necessary and advisable to amend Town Code Section 74-174 pertaining to regulations for the stopping, standing and parking of all motor vehicles including but not limited to motorcycles; and

WHEREAS, the Town Council of the Town of Griffith, Lake County, Indiana, having reviewed the relevant Town Code sections and all applicable law, now concurs that it is advisable, necessary, and in the best interests of the residents of the Town of Griffith that amendment be made to the Town Code pertaining to regulations for the stopping, standing and parking of all motor vehicles including but not limited to motorcycles.

NOW, THEREFORE, BE IT ORDAINED BY THE TOWN COUNCIL OF THE TOWN OF GRIFFITH, LAKE COUNTY, INDIANA, AS FOLLOWS:

SECTION ONE: That Town Code Sec. 74-174, entitled **Regulations for the stopping, standing and parking of all motor vehicles including but not limited to motorcycles.**, is hereby amended to include and provide as follows, namely:

“Sec. 74-174. - Regulations for the stopping, standing and parking of all motor vehicles including but not limited to motorcycles.

(b) No person shall stop, stand or park a vehicle as follows:

....

(4) Adjacent to curbing painted yellow or any other signage denoting no parking areas or within paved areas containing white paint strips.

....

(11) Within fifteen (15') feet in any direction from a fire hydrant.

(12) In front of and in ten (10') feet on either side of a vehicle delivery mailbox between the hours of 8 a.m. and 6 p.m., except on Sundays and official postal holidays.

SECTION TWO: That the other subsections of Sec. 74-174 (b) shall remain without edit.

SECTION THREE: That all existing Town Code Sections and Ordinances, or parts thereof, in conflict with the provisions of this Ordinance, are hereby deemed null, void, and of no legal effect, and are specifically repealed.

SECTION FOUR: If any section, clause, provision or portion of this Ordinance shall be held to be invalid or unconstitutional by any Court of competent jurisdiction, such decision shall not affect any other section, clause, provision or portion of this Ordinance.

SECTION FIVE: That this Ordinance shall take effect, and be in full force and effect, from and after its passage by the Town Council of the Town of Griffith, Lake County, Indiana.
