- Andy's Body Shop update: Rick Ryfa, Town Council President to follow up in a month.
- Golf Course Engineering Company was on site in the last 30 days to test ground soil.
 Engineering company finished 1st phase of boring and should take 30-40 days to finish and be ready to submit in July 2016 to the Army Corp of Engineers.
- Redevelopment Commission Members met on January 18, 2016 to discuss the 2016 Façade
 Program and potential reimbursement and grant amounts.

Outstanding and Updated items from January 2016/past meetings:

- Edward Jones Investments signed a lease in GriffLand Plaza. A Facade Application was sent to new Owner. This application has not been returned.
- Rich Leber and Rick Ryfa met with the owners of E-motors to review potential Façade Grant monies
 for the property. Metal frame and door and glass replacements were in progress at the main
 entrance vestibule at the time of the meeting. Owners reported that bids to complete wall repairs,
 wall cleaning and painting and storefront and underside marquee repairs is scheduled to commence
 when the weather breaks; pricing is still being solicited for the work. RDC tentatively pledged grant
 support if all code violations are repaired completely. There is a March 1st, 2016 deadline for work
 to be completed.
- Barcades/Restaurant is working with Engineer/Architect. A Facade Application was sent to new Owner. There has been no action at this time due to sprinkler issues.
- A 2016 Façade Application was given to the Automotive Repair Shop at the corner of Cline Avenue and Ridge Road as the Owner of the business is interested in re-painting the outer façade.
