Commission President Tim Owczarzak motioned to authorize Attorney Carol Green-Fraley to begin the amendment process, seconded by Rich Miller. All in favor, motion carried. Attorney Carol Green-Fraley will try to have the declaratory resolution for the October 2nd, 2013 meeting.

Commission President informed the Commission members that he would like to suspend the Commercial Revitalization Program. Mr. Miller motioned that the last day applications would be accepted is Wednesday, October 2nd, 2013, seconded by Mr. Kurtz. All in favor, motion carried.

OLD BUSINESS

Dan Lehnerer, of New Oberpfalz Brewery informed the Redevelopment Commission that he will be closing on the property located at 121 E. Main Street on Friday, September 27th, 2013. Neither buildings will be demolished, but will receive extensive renovations. The consumer portion of the business will be located street side and the commercial building will be in the rear. As of now, there are no plans to connect the buildings. Mr. Wiltfong asked for a timeline. Mr. Lehnerer expects the build out to take 4 to 6 months. Mr. Lehnerer will contact the Redevelopment Commission once he receives the renderings.
