Reports: Griffith Police Department

Chief Greg Mance read the monthly report for December & January.

December 2016 numbers reflect the lowest overall reported crime for any month in the past six years and most likely the lowest in 30 years of modern record keeping. Compared to previous years, crime was down 64% this past December.

For the year, 2016, overall crime fell by 13%, property crimes fell from 458 incidents reported in 2015 to 385 reported in 2016. Violent crime, which is categorized as rape, robbery, violent assaults, increased to 22 incidents from 16 the previous year. We saw an increase in robberies. Compared to last year calls for service increased by 10%. Adult arrests were up 18%, OWI arrests were up 19%, traffic stops were up 19%, and citations were up 24%.

For January 2017 crime fell by 25% as compared to January 2016 and compared to the past five January's crime fell by 37%. Comparing 2016 to 2017 for the month of January we responded to 4.5% fewer calls but we made 61.7% more traffic stops, 43% more citations, 57% more arrests, 150% more OWI arrests. We responded to 11% fewer accidents and had 71% fewer personal injury accidents.

Chief Mance reported that a new vehicle has been purchased for Chief Czerwinski as well as a truck that was previously code enforcement has been moved for use by VEST.

Chief Mance reported that we are looking to partner with the group P.A.A. R.I – Police Assisted Addiction & Recovery Initiative – which train officers in how to give someone in the addiction phase resources to get out of it through referrals to certain treatment programs. They can be fast tracked and we can make a referral for them to be placed inhouse immediately.
