Chief Mance spoke about fallen Merrillville Police Officer Nicholas Schultz. In honor of Officer Schultz and remembrance of the 2,977 victims of the 9/11 attacks and in particular of the 431 fire fighters, 2 paramedics, 8 EMT's, 60 police officers and 3 court officers died trying to save others a moment of silence was observed followed by a prayer by Sgt. Starcevich.
