- b. Council President Rick Ryfa read a request of the Griffith Youth Baseball to hold their annual parade on May 6, 2017. Council Member Tony Hobson made a motion to approve the parade. Seconded by Council Member James Marker. Motion Carried

#### BUSINESS FROM THE COUNCIL:

#### UNFINISHED BUSINESS:

a. Council Member James Marker read Ordinance 2017-20, an ordinance establishing the fees for the collection and disposal of solid waste for residential

customers at \$18.25 per month, this rate is effective until December 31, 2019. Council Member James Marker made a motion to suspend the rules and pass Ordinance 2017-20 on the first reading. Seconded by Council Member Tony Hobson. A roll call vote was taken; Council Member James Marker: in favor; Council Member Larry Ballah: in favor; Council President Rick Ryfa: in favor; Council Member Melissa Robbins: in favor; Council Member Tony Hobson: in favor. Motion carried to suspend the rules and pass Ordinance 2017-20 on the first reading. Council Member James Marker made a motion to pass Ordinance 2017-20. Seconded by Council Member Tony Hobson. Motion carried.

- b. Council Member Tony Hobson did a first reading of Ordinance 2017-21, an ordinance amending Chapter 14 Buildings and building regulations, Article II Building Code. Building Commissioner Steve McDermott explained that this ordinance establishes an inspection fee of two percent (2%) for the inspection of site, public facilities and public improvements throughout the construction process.
- c. Council Member Larry Ballah made a motion to pass Ordinance 2017-19, an ordinance amending Chapter 78 Utilities, Article III Sewer Service. Seconded by Council Member James Marker. Motion Carried.

#### **NEW BUSINESS:**

- a. Council Member Melissa Robbins read Salary Ordinance 2017-23, an ordinance updating and correcting the Town Salary Ordinance. Council Member Melissa Robbins made a motion to suspend the rules and pass Ordinance 2017-23 on the first reading. Seconded by Council Member Larry Ballah. A roll call vote was taken; Council Member James Marker: in favor; Council Member Larry Ballah: in favor; Council President Rick Ryfa: in favor; Council Member Melissa Robbins: in favor; Council Member Tony Hobson: in favor. Motion carried to suspend the rules and pass ordinance 2017-23 on the first reading. Council Member Melissa Robbins made a motion to adopt Ordinance 2017-23. Seconded by Council Member Larry Ballah. Motion Carried.
- b. Council Member James Marker made a motion to approve Resolution 2017-24, a resolution to transfer monies from fund 505: Ave. H Project, which was completed, to fund 232: Casino. The amount to be transferred is \$177,891.22. Seconded by Council Member Larry Ballah. Motion Carried.
- c. Council Member Tony Hobson made a motion to approve Resolution 2017-25, a motion to transfer monies from fund 750: Payroll Self Insurance Fund to fund 101: General. The purpose of this transfer is to account for the Town Matching Share of the Local Roads and Bridges Grant, also known as the Community Crossings Grant. Seconded by Council Member Melissa Robbins. Motion Carried.
- d. Council Member Larry Ballah made a motion to allow the Clerk Treasurer to write off outstanding checks from the year 2014 as directed by the State Board of Accounts. Seconded by Council Member Tony Hobson. Motion Carried.
- e. Council Member Melissa Robbins made a motion to approve Resolution 2017-26, a resolution amending the Town Personnel Policy Manual. This resolution allows an employee, with the approval of the Department Head, to carry over not more than forty (40) hours of vacation time from one year to the next and the hours carried over must be used within the first four (4) months of the year. Seconded by Council Member Tony Hobson. Motion Carried.

## **PUBLIC COMMENTS:**

a. Kathy Ruesken, 1103 E. Lake St., stated that there are a lot of potholes on Miller St. east of J St. Public Works Director Rick Konopasek said that he would look into it.

b. Marilyn Glinski, 1187 Sawgrass, expressed concern over a U-Tube video referring to RDA funds and HB1144. Council President Rick Ryfa stated that the Town is very aware of the impact of HB1144 and is keeping close watch on it.
