UNFINISHED BUSINESS:

- a. Council Member James Marker read Ordinance 2017-09 Corner Cutting (second reading) an ordinance making it unlawful to corner cut through a privately-owned business to avoid a controlled intersection. Council Member James Marker made a motion to approve Ordinance 2017-09, Corner Cutting, seconded by Council Member Larry Ballah. Motion Carried.
- b. Council President Rick Ryfa announced that Council assignments and appointments would be postponed until the March 7, 2017 meeting.
- c. Council President Rick Ryfa again stated that the Council would take no action at the present time on the South Shore Extension. He asked that

- individuals contact the Town Hall with their concerns and questions. The South Shore Extension will be discussed by the Town Council at the meeting on March 7, 2017.
- d. Council Member Larry Ballah read the Notice of Intent to Receive Bids for the Sale of Real Property. The property is located at 123-127 N. Wood St., Griffith, IN 46319. Sealed bids will be received beginning 12:00pm, March 1, 2017 through 4:00 pm May 1, 2017, with a minimum acceptable bid of \$156,500.00.

- b. Council Member Larry Ballah did a first reading of Ordinance 2017-12. An Ordinance approving the issuance of bonds by the Town of Griffith Sanitary District and the appropriation of the proceeds thereof.
- c. Council Member James Marker read Resolution 2017-13, A Resolution approving a temporary load from the General Fund to the Storm Bond Fund. Council Member James Marker made a motion to approve Resolution 2017-13, seconded by Council Member Larry Ballah. Motion Carried.
- d. Council Member James Marker made a motion to approve Resolution 2017-14, a resolution amending resolution 2017-10 approving and authorizing the purchase of a Ford Explorer by means of a Purchase Financing agreement with Centier Bank, Seconded by Council Member Larry Ballah. Motion Carried.
- e. Council Member Larry Ballah opened the bids for the purchase of new vehicles for the Public Works Department and made a motion that the bids be forwarded to Town Attorney Robert Schwerd and the Director of Public Works Rick Konopasek for review, seconded by Council Member James Marker. Motion Carried. The bids received were for 3 (three) new vehicles. Smith Chevrolet bid: \$107,580.00, less trade ins; Christenson Chevrolet: \$105,309.25, less trade ins.
