He was advised by Director of Public Works Rick Konopasek and Council President that because it is an off-set intersection the solutions are very limited but that the Town would be open to any reasonable suggestions he had.
- 3. David Thompson (did not give an address) asked Council President Rick Ryfa if he (Rick) was going to take over Council Member Patricia Schaadt's vacant council seat. Council President Rick Ryfa advised that one must be a resident of the ward in question in order to be considered for filling that council seat.
