- a. Motion carried, 5 in favor, none opposed.
- b. Council Member Tony Hobson made a motion to approve change order number 1 from SAK. The change order represents a savings of \$410,220.00 on the Interceptor Project. Seconded by Council Member Melissa Robbins. Motion carried, 5 in favor, none opposed.
- c. Council Member James Marker made a motion to approve change order number 2 from SAK. The change order represents an increase \$13,800.00 on the Interceptor Project. Seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor, none opposed.
- d. Council Member James Marker made a motion to award the SCADA project, including alternate, to Midwestern Electric, seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor, none opposed.
- e. Council Member Melissa Robbins made a motion to award Road Material (including concrete) project to Walsh & Kelly, seconded by Council Member Tony Hobson. Motion carried, 5 in favor, none opposed.
- f. Council Member Melissa Robbins made a motion to approve a request from the Public Works Department to advertise for bids for the replacement of aging vehicles; 2 (two) Pick-up Trucks and 1 (one) one-ton dump truck, all with plow packages, seconded by Council Member James Marker. Motion carried, 5 in favor, none opposed.

Kathy Ruesken asked if the road work on Colfax was completed because a sign was left near the corner of Lake St. and Colfax. She was advised to contact Lake County as this was a County road project.
