NEW BUSINESS:

- a. Council Member James Marker made a motion to approve Resolution 2018-31, a resolution requesting additional appropriations to correct a budgeting error in the Parks and Recreation Department, seconded by Council Member Lawrence Balla. Motion carried, 5 in favor none opposed.
- b. Council Member Melissa Robbins made a motion to approve Resolution 2018-32, a resolution requesting additional non-levied appropriations, seconded by Council Member Tony Hobson. Motion carried, 5 in favor none opposed.
- c. Council Member Lawrence Ballah gave a brief synopsys of the 2018 Calumet Township tax rate vs. Surrounding Townships: The tax rates are: Calumet:0.347; North: 0.0789; St. John: 0.0111. Council Member Tony Hobson gave a brief synopsys of the Projected Property Tax Levies: Calumet: \$2,173,845.00; North:\$499,922.00; St. John: \$69,538.00. Council President Rick Ryfa stated that the full analysis will be posted to the Town website when it is finalized and approved. He also stated that there will be a special email address that residents can use to ask questions about the Township issue and updates and current information will be posted on the Town website.

PUBLIC COMMENTS:

Richard Cook asked when the webpage would be up. He was advised that it would be up by Friday, October 5, 2018. He was also advised that there would be no decision for at least 30 days on which Township we will join. That portion of Griffith that is in St. John Township will stay in St. John Township regardless of which Township Griffith moves to and there will be no change in the School structure.

Mike Gaby: Congradulated the Council on their victory. He went on to say that this started 10 years ago by his father, Bud Gaby, George Jerome and Rick Ryfa and that this is proud moment for everyone. This issue has nothing to do with politics and everything to do with bad stewardship. All of the hard work is greatly appreciated.

Adam Schroader asked if House District Maps would be redrawn. He was advised that the maps would not be redrawn.
