- PENDING ITEMS:

**TOWNSHIP ISSUES:** Calumet Township Secession update: Council President Rick Ryfa and Council Members James Marker and Tony Hobson attended a meeting with North Township members. # PUBLIC COMMENT ON AGENDA ITEMS: None BUSINESS FROM THE COUNCIL:

#### **UNFINISHED BUSINESS:**

- a. Council Member Melissa Robbins made a motion to approve Ordinance 2018-48, an ordinance of the Town of Griffith approving the issuance of bonds of the Town of Griffith Park District, seconded by Council Member James Marker. Motion carried, 5 in favor, none opposed.
- b. Council Member James Marker made a motion to continue Ordinance 2018-49, an ordinance amending Town Code Section 74-175 entitled "Parking and Storage of RVs, Motor Homes, Boats, Boat Trailers, Recreational Equipment and Trailers Generally" until a future date to be determined, seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor, none opposed.
- c. Council Member Tony Hobson did a first reading of Ordinance 2018-50, an ordinance amending Town Code Section 62-80 entitled "placement" of containers for the deposit of garbage or rubbish. This was a second first reading of this ordinance due to significant changes made after its' first reading on November 20, 2018.

#### **NEW BUSINESS:**

- a. Council Member Lawrence Ballah made a motion to approve Resolution 2018-51, a resolution to transfer appropriations within the General Fund, seconded by Council Member James Marker. Motion carried, 5 in favor none opposed.
- b. Council Member James Marker did a first reading of Ordinance 2018-52, Salary Ordinance for 2019.
- c. Council Member Melissa Robbins made a motion to allow Clerk Treasurer John Volkmann to sign a License Agreement with NIPSCO, seconded by Council Member Town Hobson. Motion carried, 5 in favor none opposed.

#### **PUBLIC COMMENTS:**

Kathy Rueskin asked if a front porch was considered part of the main structure. Chief Mance replied that the front of the house, not the porch was considered the front of the structure.

Al Bjorec asked if there was an ordinance that addressed "air bnb" rentals. Coucil President Ryfa responded that there was not but it is something the Council may look into in the future.

Kathy Kepchar asked about the comments made by Hammon Mayor McDermott that he will "do everything in my power to keep Griffith out of North Township" and that Trustee Frank Mrvan seemed to be backtracking on the request. Council President Ryfa responded with "Lake County Politics". He also stated that the Town has presented a very strong position as to why it should be accepted into North Township. Council Member Marker added that North Township seemed to be very open minded and just needed a few more details.

George Smolka stated that for health reasons he could not always put his trash containers back where they belong in the time allotted in the ordinance. He was advised to call Public Works should this happen.

Kathy Rueskin and George Smolka asked about large items left for pickup. They were advised to call Public Works and they will make sure the items are picked up. Marilyn Glinski asked why there were still signs posted about homes being available in the Trail Creek subdivision. Building Commissioner Steve McDermott said he would look into the matter.

There being no further business to come before this Council, the meeting was adjourned at 7:39 p.m.
