TOWNSHIP ISSUES: Calumet Township Secession update: Council Presedent Rick Ryfa announced that to date residents have voted the following: 101 for St. John Township; 41 for North Township; and 4 for either. He also announced that Reedy Financial will do an analysis of debt impact on the two townships. Golf Course: The Town is still in negotiations with the EPA and the Army Corps of

During discussion of the motion it was pointed out by Rick Konopasek, Director of Public Works, that the cost distribution would probably be a little different with less coming from Storm. Council Member James Marker amended his motion to remove the percentages from each fund to be used, seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor none opposed.
- b. Council Member Tony Hobson made a motion to approve Resolution 2018-36, a resolution for an Excess Levy Appeal, seconded by Council Member Melissa Robbins. A voice vote was taken: Council Member James Marker Aye; Council Member Lawrence Ballah Aye; Council President Rick Ryfa Aye; Council Member Melissa Robbins Aye; Council Member Tony Hobson Aye. Motion carried 5 in favor none opposed.
- c. Council Member Lawrence Ballah did a first reading for Ordinance 2018-37, an ordinance amending Town code secton 74-301 entitled "Parking Prohibited at all Times".
