NEW BUSINESS:

- a. Council Member Lawrence Ballah made a motion to approve Resolution 2019-06, a resolution to transfer appropriations within the Events Fund, seconded by Council Member James Marker. Motion carried, 5 in favor none opposed.
- b. Council President Rick Ryfa opened the Public Hearing for the Additional Appropriation Request. There being no remonstrances the Public Hearing was closed.
- c. Council Member James Marker made a motion to approve Resolution 2019-07, a resolution authorizing additional non-levied appropriations, seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor none opposed.
- d. Council Member James Marker made a motion to approve Resolution 2019-08, a resolution authorizing additional appropriations, seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor none opposed.
- e. Council Member Tony Hobson introduced Ordinance 2019-09, an ordinance authorizing a new recycling fund 270. Council Member Lawrence Ballah made a motion to suspend the rules and pass Ordinance 2019-09 on the first reading, seconded by Council Member James Marker. A voice vote was taken: Council Member James Marker: in favor; Council Member Lawrence Ballah: in favor; Council President Rick Ryfa: in favor; Council Member Melissa Robbins: in favor; Council Member Tony Hobson: in favor. Motion carried 5 in favor none opposed. Council Member Tony Hobson made a motion to approve Ordinance 2019-09, an ordinance authorizing a new recycling fund 270, seconded by Council Member Melissa Robbins. Motion carried, 5 in favor none opposed.
- f. Council Member Tony Hobson made a motion to approve Resolution 2019-10, a resolution to transfer appropriations from Recycling 203 to Recycling 270, seconded by Council Member Melissa Robbins. Motion carried, 5 in favor none opposed.
- g. Council Member Lawrence Ballah made a motion to approve Resolution 2019-11, a resolution to establish Fund 203 MVH Restricted and the transference of appropriations as directed and ordered by the State Board of Accounts, seconded by Council Member James Marker. Motion carried, 5 in favor none opposed.
- h. Council Member Melissa Robbins made a motion to approve an interlocal agreement between the Griffith Public Schools and the Town of Griffith for purpose of sharing the expenses related to training a Griffith Public Schools Maintenance Worker/Custodian to serve in the capacity as a Certified Playground Safety Inspector. Said Inspector will be utilized by the Town of Griffith to help facilitate inspections of Town owned playground equipment and insure said equipment and playground areas overall comply with Local, State and Federal guidelines, seconded by Council Member Tony Hobson. Motion carried, 5 in favor none opposed.

PUBLIC COMMENTS:

Elizabeth Cordova asked if anything can be done to alieviate the parking congestion on Pine St. at Central Park during the baseball season. She stated that she lives across the street from the baseball area and during games there is no where to park near her home because of the games. Council President Rick Ryfa asked Police Chief Greg Mance to look into the issue and see what could be done about it. He advised MS Cordova that there would be an answer in about 2 (two) weeks.
