#### **NEW BUSINESS:**

- a. Council Member Melissa Robbins read a letter from Republic Services about the expiration of the current contract, the potential of a contract extension and about the current recycling market and the need to negotiate pricing that will reflect the true costs of recycling.
- b. Council Member Tony Hobson made a motion to approve resolution 2019-22, a resolution approving a temporary loan from the Sewer Capital Reserve Fund to the Bond Temporary Transfer Fund in the amount of \$250,000.00, seconded by Council Member Melissa Robbins. Motion carried, 5 in favor none opposed.
- c. Council Member James Marker made a motion to approve a supplemental agreement with Butler, Fairman and Suefert for design services for the Reder Road water main extension to the Turnberry Subdivision, the cost of the supplement is not to exceed \$16,500.00, seconded by Council Member Tony Hobson. Motion carried, 5 in favor none opposed.
- d. Council Member Melissa Robbins made a motion to appoint Larry Stassin to the Plan Commission, seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor none opposed.
- e. Council Member Tony Hobson did a first reading of Ordinance 2019-20, an ordinance vacating a public way at 1001 W. Main St. Griffith, Indiana.
- f. Council Member Lawrence Ballah did a first reading of Ordinance 2019-23, an ordinance amending Chapter 74 of the Town of Griffith Code adding article IX and authorizing the use of golf carts and recreational off road vehicles on the streets and alleys of the Town of Griffith.
- g. Council Member James Marker made a motion to approve Resolution 2019-24, a resolution authorizing the purchase of a new Chevrolet Silverado 1500 for the Parks and Recreation Department, seconded by Council Member Lawrence Ballah. Motion carried, 5 in favor none opposed.

## PUBLIC COMMENTS:

An unknown woman complimented the Town Council on the successful Rock N Rail festival.

Tim Diamond asked if Golf Carts would have to have safety equipment similar to automobiles. Rick Ryfa advised that the carts would have to have headlights and breaklights and be insured.

An unknown male asked how feasible is it for the Town to provide Township services to its' residents. Rick Ryfa advised that it was very feasible.
