Council Member Melissa Robbins made a motion to approve a Highland/Griffith Interlocal Agreement for the resurfacing of Cline Ave. from Ridge Road to 100' South of 45th Ave. as part of the 2019 Community Crossings Matching Grant, the Griffith share is \$77,730.16, seconded by Council Member Tony Hobson. Motion carried, 5 in favor none opposed.
