Chrissy Braun asked about the survey for flooding, asked how it would be distributed. Should be out by end of week.

Bob McGinnis asked for an update. He stated the State of Indiana would issue a license up to 3 months. Asking if the fees would be the same for multi dwelling. He stated Hud considers the mobile home park a multi home dwelling. 41 lots. Council President stated we would need to be clear if the mobile home park is a multi-family dwelling. Council President stated we are committed to this. Council President requested Mr. McGinnis to call him in 30 days.
