- CCMG Approval of Roadwork: Central Park Sidewalk Replacement: The
 construction bids for the 2021 Street Resurfacing Project have been received on April 1,
 2021 and found Milestone Contractors to be the lowest, responsive, and responsible
 bidder with an actual low bid of \$1,066,133.30 which is less than the Engineer's
 Estimate. Council Member Tony Hobson made a motion to award the contract to
 Milestone, seconded by Council Member Melissa Robbins, Motion Carried.
- 2. Findings of Facts Safeway Auto Finance: Application of Safeway Auto finance for a variance of use to operate a used car dealership at 100 E Ridge Rd., IN A. B. -3 Zoning, the Petitioner has shown that approval of the Use variance does not substantially interfere with the Master Plan because Petitioner's proposed use is a business use which is not wholly inconsistent with the uses permitted in a B-3 Zoning District.
