PUBLIC COMMENTS:

- Terry Schafer, 315 N Jay St spoke about the desirability of preserving the old Library Building at Main and Broad. He suggested that the Town purchase it or impose restrictions on buyers in order to preserve a significant landmark
- Jim Konopasek, 311 W 44th spoke in support of Mr. Schafer's comments and stated the need to preserve Town history. He stated that the building would be an ideal repository of preserved family histories.
- Cecil Wright, 207 N Lafayette suggested that the Historical Society purchase the building and restore it as an Ice Cream Parlor similar to what Dr Egnatz's wife did a number of years ago.
- Council President Ryfa explained the law regarding the purchase of real property and stated that it would prevent the town from purchasing the property. He also stated that the Historical Society is probably not in a position to purchase it without a major source of funding.

WHEREAS Fibromites Unite, the National Fibromyalgia & Chronic Pain Association, and other groups around our country have joined together to promote fibromyalgia awareness and support - including improved education, diagnosis, research and treatment,

NOW THEREFORE, as President of the Town Council of the Town of Griffith, Indiana I do hereby recognize the needs of these chronically ill people and proclaim May 12, 2016 as "Fibromyalgia Awareness Day" in Griffith, Indiana and urge all of our citizens to support the search for a cure and assist those individuals and families who deal with this devastating disorder on a daily basis.
