UNFINISHED BUSINESS: NONE

NEW BUSINESS:

1. **Interlocal Government Agreement:** Between the Town of Griffith and the Griffith Public Schools. Whereas the Town desires to provide a Town of Griffith Police Officer to the School District to serve in the capacity as School Resource Officer, Council Member Larry Ballah made a motion that we allow our President to sign this agreement on behalf of the Town, seconded by Council Member Tony Hobson, Motion Carried.
2. **Resolution 2022-37 A Resolution to Transfer Appropriations:** Whereas there is a need to transfer monies from various funds to the Local Roads and Bridges Fund for the sole purpose of establishing the matching funds for the Local Roads and Bridges Grant (LR&B), also known as the Community Crossing Matching Grant. Council Member Jim Marker made a motion authorizing approval of Resolution 2022-37, seconded by Council Member Larry Ballah, Motion Carried.
3. **Ordinance 2022-38 Appropriations and Tax Rates:** Council Member Tony Hobson stated there will be a public meeting in October. This is a go ahead to introduce Ordinance No. 2022-38. Council President Rick Ryfa stated as we do every year there are uncertainties going into the 1782's we receive at the beginning of the year, we typically advertise higher than we anticipate will be approved just to make sure we have everything covered in case there are any issues over the next couple of months.
4. **General Services Agreement – BF&S-Main Street Stormwater Outlet & Ave D & E Stormwater Study:** Butler, Fairman & Seufert, Inc. is pleased to submit this proposal to the Town of Griffith for providing services related to storm water evaluation for the upcoming Main Street Improvements (Wood Street to Colfax) and the Ave D & E area afflicted by recent flooding concerns (Broad Street from RR tracks to Ave H) Upon notification to proceed by October 7th, the Main street Storm Sewer Evaluation can be completed by November 30, 2022, and the Avenue D & E Evaluation can be completed by March 31, 2023. Council Member Jim Marker made a motion authorizing Town Council President Rick Ryfa and Director of Public Works Andy Raab to sign off, seconded by Council Member Larry Ballah, Council Member Tony Hobson stated for the record the total is \$16,500.00 for the work, Motion Carried.
5. **Change Order No. 3 – BF&S Reder Road Water Main:** On September 16, 2022, there was a Reder Road Water Main change order number three and the total for the change order is \$120,000.00, there were four different items that needed to be changed. Council Member Tony Hobson made a motion to approve Change order number three on the Reder Road project, seconded by Council Member Larry Ballah, Motion Carried.

 - a. Construction Update: Due to concrete shortage we have not gotten a lot done in the last week, been focusing on the restoration and we will be getting a couple of crews started again next week and back on track. Cline Avenue will be our next big area focused on getting completed.



There being no further business to come before this Council, the meeting adjourned at 7:18 p.m.


