**NEW BUSINESS:**

1. BZA Appointments: Council Member Jim Marker made a motion to fill the vacancy position with Jason Nolasco, seconded by Council Member Larry Ballah, Motion Carried.
2. Wood Street Storm Water Lift Station Evaluation-Supplement No. 1- This is to include the expanded evaluation of the Wood Street Lift Station to include the evaluation of the Brinwood Storm Water Lift Station, Butler Fairman & Seufert will utilize the 2008 study to evaluate the current needs of the Town. The evaluating shall be added to the task order increasing the total lump sum amount from \$29,000.00 to \$50,500.00. Council Member Melissa Robbins made a motion that we allow Council President Rick Ryfa to sign this agreement, seconded by Council Member Larry Ballah, Motion Carried.
3. Reder Road Water Main-Pay Estimate No. 3: This is for the work on Redar Road water main for the total amount of \$114,411.49, Council Member Melissa Robbins made a motion that we pay this amount, seconded by Council Member Larry Ballah, Motion Carried.
4. Milestone Contractors North, Inc. Change Order No. 1: This is for additional work, patching existing sidewalks that did not get replaced. Unit price will be \$110.00 a yard, it does not affect the contract amount per se at this point of time. Council Member Larry Ballah made a motion that we grant Change Order No. 1, seconded by Council Member Jim Marker, Motion Carried.
5. Council Member Jim Marker stated at the previous meeting we had awarded the contract for Central Park phase two, to Precision, it is now we come to this meeting to now to approve Central Park Phase Two to Precision and this is not to exceed \$1,168,830.00. Council Member Jim Marker made a motion that we have Precision complete Central Park Phase Two, seconded by Council Member Melissa Robbins, Motion Carried

1. PD/Town Hall Construction: For right now the Town Council has decided to put the new construction on permanent hold until we see what happens to the economy with the supply chain as well as the cost escalated very high, at this time the project is on hold until we revisit sometime next year.


**Public Comment:**
