- 1. **Ordinance 2025-1: Amended Salary Ordinance:** Council Member Jim Marker stated this has no Salary change, it aligns with the contract with the FOP, Marker made a motion to suspend the rules, seconded by Council Member Melissa Robbins, roll call taken, all in favor, motion carried, rules suspended, Council Member Jim Marker made a motion to approve Ordinance 2025-1, seconded by Council Member Melissa Robbins, all in favor, Motion Carried.
- 2. **Ordinance 2025-2: Establishing Police Body Camera Footage Fees:** Council Member Melissa Robbins made a motion to suspend the rules, seconded by Council Member Tony Hobson, roll call taken, all in favor, motion carried, rules suspended, Council Member Melissa Robbins made a motion to pass Ordinance 2025-2, seconded by Council Member Tony Hobson, all in favor, Motion Carried.
- 3. **Extension of existing Yearly Asphalt Paving Contract from 2024 through 2025, Milestone:** Council Member Tony Hobson made a motion to allow Town Council President to enter into the agreement, seconded by Council Member Melissa Robbins, all in favor, Motion Carried.
- 4. **Authorization to Advertise 2024-2 Griffith CCMG Project:** Council Member Jim Marker made a motion authorizing us to advertise, seconded by Council Member Melissa Robbins, Ryfa stated this is simply the last that we were awarded \$1.5 million matching grant from the CCMG from the state last year. The projects we had on Main Street came in much lower than anticipated. Left over funds and to spend those we need to advertise the additional projects that were approved by the state. 50/50 with the Town picking up half the cost of these projects. This is a continuation of work on Main Street, mostly paving and some curb work, not as extensive as the rebuilding. All in favor, Motion Carried.
- 5. **2025 Continuing Disclosure Filings, Financial Solutions Group:** Council Member Tony Hobson made a motion to enter into the agreement with Financial Solutions Group, seconded by Council Member Melissa Robbins, all in favor, Motion Carried.
- 6. **Proposal For Professional Services Financial Solutions Group:** Council Member Tony Hobson made a motion to enter into the agreement with Financial Solutions Group, seconded by Council Member Melissa Robbins, all in favor, Motion Carried.
- 7. **Board Appointments:**
 - RDC:** Council President Rick Ryfa appointed: Melissa Robbins, Tony Hobson, and Rich Miller. Council Member Melissa Robbins made a motion to appoint Rick Ryfa and Larry Ballah, seconded by Council Member Jim Marker, all in favor, Motion Carried.

Park Board: Council Member Jim Marker nominated Tim O'Brien, seconded by Council Member Tony Hobson, no other nominations, all in favor, Motion Carried.

Lake County Solid Waste Management District: Council President Rick Ryfa made a motion to appoint himself and Jim Marker to the board, seconded by Council Member Tony Hobson, all in favor, Motion Carried.

Water Board, Finance Board and the Board of Public Works: All comprised of the Griffith Town Council, Ryfa entertained a motion to collectively appoint the Town Council to each of the Boards respectively, so moved by Council Member Tony Hobson, seconded by Council Member Melissa Robbins, all in favor, Motion carried.


Public Comment:

Chief Mance accepted the donation and stated the animal shelter needs this, with the generosity of the Town Council and many residents in town we totally built a new academy, repurposed the building and greatly expanded our services and the number of animals that we can care for, this was over a decade ago and a great need to make many improvements and repairs, it is as if prayers were answered because this couldn't have come at a better time. The chief was very thankful for the gift.

There being no further business to come before this Council, the meeting adjourned at 7:21 p.m.


