- 3. Council President Rick Ryfa read a letter from Enbridge regarding the planting of trees in temporary work easement areas adjacent to the 6B Pipeline. They will plant a total of 12 trees.

- c. Council Member Larry Ballah presented the BZA Findings of Fact regarding 45th Street Studios' request for a variance to operate a tattoo shop and art gallery in a B-2 Zoning District. The BZA made a favorable recommendation with a 3-2 Vote.
 - i. Council Member Larry Ballah moved to affirm the BZA's Findings of Fact, second by Council Member Pat Schaadt. With clarification by Council President Ryfa that a YES vote would affirm the BZA's recommendation to grant the variance while a NO vote would deny the variance. MOTION FAILED, thereby denying the requested variance.
 - ii. Town Attorney Schwerd will prepare new Findings of Fact
- d. Council Member Larry Ballah introduced on 1st reading, Ordinance 2015-09: An Ordinance Regarding Alarms.
- e. Council Member Stan Dobosz introduced Ordinance 2015-10: A Revised Salary Ordinance.
 - i. Because the only revision was to create a part-time position in the Police Department to facilitate the E-911 consolidation, Council Member moved to suspend the rules and vote on passage at this meeting, second by Council Member Larry Ballah. In a roll call vote, all voted to suspend the rules.
 - Council Member Larry Ballah moved to approve Salary Ordinance 2015-10, second by Council member Pat Schaadt. MOTION CARRIED

- f. Council Member Pat Schaadt moved to pass Resolution 2015-11: A Resolution Transferring Appropriations, seconded by Council Member Larry Ballah. MOTION CARRIED
- g. Council Member Pat Schaadt moved to grant the Griffith Historical Society \$5,000 for the continuation of their efforts to collect, preserve and display artifacts significant to Griffith's history, second by Council Member Larry Ballah. MOTION CARRIED
- h. Council Member Pat Schaadt moved to authorize Council President Rick Ryfa to sign a Master Services Agreement with Weaver Consultants Group North Central LLC, second by Council Member Larry Ballah. MOTION CARRIED
