a. Council Member Stan Dobosz moved to approve Ordinance 2014-08: An
Ordinance Amending the 2014 Salary Ordinance, second by Council
Member Pat Schaadt. MOTION CARRIED

2. NEW BUSINESS

- a. Council Member Larry Ballah introduced on first reading, Ordinance
 2014-03: An Ordinance Regarding Sign Landscaping Requirements.
- b. Council Member Pat Schaadt introduced on first reading, Ordinance
 2014-09: An Ordinance Prohibiting Parking in Front of Rural Mailboxes.
- c. Council President Rick Ryfa discussed the need for a documented Capital Spending Plan in order for the county to release our CEDIT Funds. The expected uses are 75% for roads, 12.5% for capital equipment and 12.5% for economic development.
 - i. John Julien explained ways in which the CEDIT Funds could be leveraged by creating a Building Corporation to bond for \$5-\$8 million that would be retired from a combination of CEDIT, TIF and Stormwater Funds. The advantage would be that there would be no impact on property taxes. He also discussed the possibility of refinancing the existing Stormwater bond to take advantage of reduced interest rates.
 - ii. Council Member Stan Dobosz moved to have John Julien and Bob Schwerd get started on the creation of a Building Corporation, second by Council Member Pat Schaadt. MOTION CARRIED
- d. Council President Rick Ryfa introduced the Neighborhood Improvement Plan, explaining that after the successful efforts to improve the business district, attention will now focus on residential neighborhoods by creating incentives for property owners to improve their properties as well as adopting an aggressive road repair plan.
 - i. Council Member Glen Gaby moved to approve Resolution 2014-10: A Resolution Establishing the Neighborhood Home Improvement Initiative, second by Council Member Pat Schaadt. MOTION CARRIED
 - ii. Council Member Larry Ballah moved to approve a proposal by Robinson Engineering to reevaluate and rate roads in order to prioritize repairs, second by Council Member Glen Gaby. MOTION CARRIED
- e. The RFQ for the Erie Lakawanna Trail Connector Project were opened. Five firms responded: 10 SHE, Nies, Robinson, BF&S and Weaver Boos. Council Member Pat Schaadt moved to take the RFQ's under advisement, second by Council Member Glen Gaby. MOTION CARRIED

- Barb Schweitzer, 315 N Broad questioned the need to have curbside pick-up of trash
- Donald Rosenberger, 1706 Westfield Court discussed the need for an ordinance regarding parking by rural mailboxes
- Florine Weston, 1712 Westfield Court thanked the council for taking action regarding parking by rural mailboxes (Ordinance 2014-09)

ORDINANCE 2014-03

AN ORDINANCE AMENDING CHAPTER 86 ZONING; ARTICLE XVI. SIGNS; SECTION 86-233, LANDSCAPING.

WHEREAS, in order to protect the public health, safety, morals, and general welfare, as well as conservation of property values throughout the Town of Griffith, the Griffith Town Council believes it should regulate landscaping installed near proposed signs within Town; and

WHEREAS, in order to provide for the orderly development of the Town of Griffith, and the Town of Griffith Plan Commission having held a public hearing, and the Plan Commission having recommended that the Town Council adopt this Ordinance; and

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Griffith, Lake County, Indiana, that Chapter 86 Zoning, Article XVI. Signs, Section 86-233, Landscaping, subsection (a) of the Town ordinances is hereby amended in its entirety and shall hereafter read as follows, and that all other portions of said Section 86-233 shall remain unchanged: Section 86-233. Landscaping.

(a) Prior to the issuance of any sign permit for a self-supported ground sign, a landscaping treatment plan shall be submitted to the Building Department showing the location of the sign and landscape treatment to be provided. Should the Building Department disapprove the design, then the Board of Zoning Appeals shall make the final decision with no public hearing being necessary.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after its passage and posting in accordance with Indiana Code 36-5-2-10.

ORDINANCE 2014-09

AN ORDINANCE AMENDING CHAPTER 74 TRAFFIC AND VEHICLES, ARTICLE V STOPPING, STANDING AND PARKING, SECTION 74-174 REGULATIONS FOR THE STOPPING, STANDING AND PARKING OF ALL MOTOR VEHICLES INCLUDING BUT NOT LIMITED TO MOTORCYCLES, TO PROHIBIT PARKING IN FRONT OF RURAL DELIVERY MAILBOXES.

WHEREAS, it is vital to the public health, safety and welfare of the residents of the Town of Griffith that mailboxes be unobstructed by vehicles so that mail can be timely and efficiently delivered to residents;

NOW, THEREFORE, BE IT ORDAINED by the Town Council of the Town of Griffith, Lake County, Indiana, that Chapter 74 Traffic and Vehicles, Article V Stopping, Standing and Parking, Section 74-174(b) be amended to add subparagraph (11) as follows:

In front of and 10 feet on either side of a vehicle delivery mail box between the hours of 8 a.m. and 6 p.m., except Sundays and official postal holidays.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect after is passage and posting in accordance with IC 36-5-2-10.
