A RESOLUTION BY THE TOWN COUNCIL OF THE TOWN OF GRIFFITH AUTHORIZING THE PURCHASE OF 530 S. INDIANA AVENUE

The prefatory paragraphs above are incorporated herein by reference as if more fully stated herein. The Town Council of the Town of Griffith now finds and determines that the real property commonly known as 530 S. Indiana Avenue, Griffith, Indiana, 46319, with Parcel Number 45-11-02-328-025.000-006, and more particularly described as Lots 32, 33 and 34 in F.R. Mott's Addition to the Town of Griffith in Lake County, Indiana, as per plat thereof, should be accepted by the Town of Griffith as a gift, contingent upon the Grantor's ability to deliver clear title to the property.

NOW, THEREFORE, BE IT FURTHER RESOLVED that the Clerk-Treasurer be authorized to remit payment for the purchase of the above described real property, if the Grantor is able to deliver clear title to the property.

AN ORDINANCE AMENDING CHAPTER 74 TRAFFIC AND VEHICLES; ARTICLE VIII., TRAFFIC SCHEDULES; SECTION 74-301(a) PARKING PROHIBITED AT ALL TIMES; TO PROHIBIT PARKING NEXT TO THE LIBRARY BRANCH ON THE EAST SIDE OF THE 800 BLOCK OF NORTH WHEELER AVENUE

WHEREAS, the health, safety, and general welfare of the citizens of the Town of Griffith demands that Ordinance 74 Traffic and Vehicles, Article VIII Traffic Schedules, Section 74-301(a) Parking Prohibited at All Times be amended by prohibiting parking at all times on the east side of the 800 block of North Wheeler Avenue next to the 45th & Colfax Library Branch.

NOW, THEREFORE, BE IT ORDAINED, by the Town Council for the Town of Griffith, that Municipal Code, Chapter 74 Traffic and Vehicles, Article VIII. Traffic Schedules, Section 74-301(a) Parking prohibited at all times, be amended by adding the following row to its schedule:

AN ORDINANCE AMENDING CHAPTER 14 BUILDINGS AND BUILDING REGULATIONS; ARTICLE II., BUILDING CODE; DIVISION 5. FEES AND CHARGES; SECTION 14-106 FEES FOR SIGN PERMITS

WHEREAS, IC 36-1-3-2 confers upon all local units the powers that they need for the effective operation of government as to local affairs; and

WHEREAS, IC 36-1-3-6(b)(1) prescribes that any such exercise of power shall be authorized through enactment of an ordinance passed by the legislative body; and

WHEREAS, the Town of Griffith is a municipal government which may pass and codify ordinances for its operation, all pursuant to IC 36-1-4 and IC 36-1-5; and

WHEREAS, the Town Code for the Town of Griffith currently requires that fees for sign applications to be computed based on the valuation of the proposed sign, with no maximum fee stated; and

WHEREAS, the Town Council believes that it is best for the public health, safety, and welfare for the Town of Griffith that the fees for sign applications instead be limited to a maximum of \$250.00, exclusive of inspection fees, and

NOW, THEREFORE, BE IT ORDAINED, by the Town Council for the Town of Griffith, that Municipal Code, Chapter 14 Buildings and Building Regulations, Article II. Building Code, Division 5. Fees and Charges, Section 14-106 Fees generally, be amended by replacing the Sign Fees subsection in its entirety as follows:

Sign Fees:

Valuation fee:

\$0.00—\$500.00\$30.00

Per additional \$500.00 of incremental value thereof\$15.00, not to exceed \$250.00

Footing inspection fee\$30.00 per inspection Electrical inspection fee\$30.00 per inspection No fee for nonprofit temporary sign

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after its passage and posting in accordance with Indiana Code 36-5-2-10.

AN ORDINANCE AMENDING CHAPTER 2 ADMINISTRATION; ARTICLE V., FINANCE; DIVISION 4. POLICE DEPARTMENT ADMINISTRATIVE SERVICES

WHEREAS, IC 36-1-3-2 confers upon all local units the powers that they need for the effective operation of government as to local affairs; and

WHEREAS, IC 36-1-3-6(b)(1) prescribes that any such exercise of power shall be authorized through enactment of an ordinance passed by the legislative body; and

WHEREAS, the Town of Griffith is a municipal government which may pass and codify ordinances for its operation, all pursuant to IC 36-1-4 and IC 36-1-5; and

WHEREAS, the Town Code for the Town of Griffith currently requires that fees be charged for certain administrative functions provided by its Police Department; and

WHEREAS, the Town Council believes that it is best for the public health, safety, and welfare for the Town of Griffith that the fees for administrative services provided by its Police Department be updated, from time to time, and

NOW, THEREFORE, BE IT ORDAINED, by the Town Council for the Town of Griffith, that Municipal Code, Chapter 2 Administration, Article V. Finance, Division 4. Police Department Administrative Services, Section 2-210 Services provided and fees specified, be amended by:

increase the fee titled "Vehicle Release" from \$20.00 to \$25.00; increase the fee titled "Fingerprints (nonresident)" from \$10.00 to \$20.00; and insert a new fee line item titled "Vehicle release due to arrest" for "\$50.00.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that all other portions of said Section 2-210 shall remain unchanged and in full force and effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after its passage and posting in accordance with Indiana Code 36-5-2-10.

AN ORDINANCE AMENDING TOWN CODE CHAPTER 14 BUILDINGS AND BUILDING REGULATIONS, ARTICLE II BUILDING CODE, DIVISION 5 FEES AND CHARGES, TO ADD NEW SECTION 107 TO IMPOSE INSPECTOR RESTRICTIONS ON WORK SITES.

WHEREAS, IC 36-1-3-2 confers upon all local units the powers that they need for the effective operation of government as to local affairs; and

WHEREAS, IC 36-1-3-6(b)(1) prescribes that any such exercise of power shall be authorized through enactment of an ordinance passed by the legislative body; and

WHEREAS, the Town of Griffith is a municipal government located in Lake County, Indiana, which may pass and codify ordinances for its operation, all pursuant to IC 36-1-4 and IC 36-1-5; and

WHEREAS, the Town Council for the Town of Griffith has determined that the public health, safety, and welfare of the residents of the Town of Griffith requires that building inspectors employed by the Town not be permitted to inspect worksites for which they have previously served as a consultant or for which they have previously provided an estimate or bid for a project that is to be commenced within the Town; and

NOW, THEREFORE, BE IT ORDAINED, by the Town Council for the Town of Griffith that Town Code Chapter 14 Buildings and Building Regulations, Article II Building Code, Division 5 Fees and Charges, be amended to add a new Section 14-107 to read as follows:

Sec. 14-107. Inspectors.

No inspector for the Town of Griffith shall inspect a work site for which the inspector has been previously consulted, or has given an estimate or bid. It shall be the responsibility of the property owner to notify the Town in the event that the inspector was previously consulted, or provided an estimate or bid on the project.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that this Ordinance shall be in full force and effect from and after its passage and posting in accordance with Indiana Code 36-5-2-10.

Sec. 2-131. Personnel Policy Manual.

The <u>Personnel Policy Manual for the Town of Griffith, Lake County, Indiana</u> is hereby adopted, established and deemed to be a part of this chapter as fully and completely as if it was physically incorporated into the Griffith Code Book. A copy of this Ordinance shall be bound separately from the Code of Ordinances and be available to the public at the Griffith Town Hall.

NOW, THEREFORE, BE IT FURTHER ORDAINED, that any and all such Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with the provisions of this Ordinance are hereby repealed and of no further force or effect.

This Ordinance shall be in full force and effect from and after its passage and following posting in accordance with Indiana Code 36-5-2-10. All other Ordinances or parts of Ordinances of the Town of Griffith that are in conflict with this Ordinance are hereby repealed to the extent of such conflict.
